# JetBlack NSW All Schools Cross Country MTB Championship - 2010

Entry Conditions and Parent/Guardian Indemnity & Waiver for Riders

This form, signed by the Rider, and the Parent/Guardian of the rider must be brought to race registration collated by the supervising teacher/parent for the school before the rider will be allowed to enter. NO FORM – NO RACE !!

Note: Mountain Biking is a hazardous experience or activity, with varying surface and environmental conditions. It is different from road cycling in that it is done on partially improved and unimproved trails and roads, as well as on naturally rugged terrain.

The Organisers are NSW Mountain Bike Association and Western Sydney Mountain Bike Club, along with their officers, directors, employees, volunteers, agents, contractors and sponsors. The Event is the NSW All Schools XC Mountain Bike Championship.

I am in good physical condition and have no disability, impairment or ailment that will prevent me from engaging in the Event or that will be detrimental to my health, safety or physical condition of others while participating in the Event or while at or near the Event. I understand the risks associated with Mountain Biking and that I must wear an Australian Standards approved helmet. The bike must be in good working order with efficient and well maintained brakes, tyres, chain and gears, etc. I undertake to practise the course before commencing the race Event, and if this is not possible, then ride with due regard with the knowledge that I have not examined the course. I hereby agree to allow the rider’s name, results, photographs, video, audio recordings, multimedia or film likeness to be used for any legitimate purpose by the Organisers.

I hereby release and hold harmless, and forever discharge the Organisers from any and all claims, suits, demands, costs, actions and proceedings of any nature whatsoever, which I, my executors or administrators or any other person has or might assert against the Organisers arising from, in relation to, incidental to or by virtues of any injury loss, or damage suffered or sustained by me in conjunction with my participation in the Event or at any time I am near the Event, or any injury loss or damage suffered by any other person as a result of any act or omission, neglect or default on my part in conjunction with my participation in the Event or at any time I am near the Event.

I acknowledge that MTBA Day Licence insurance covers me for public liability and personal indemnity whilst participating in this Event. I agree that I am responsible for my personal accident insurance, ambulance cover and medical costs not covered by the MTBA Day Licence Insurance.

The Organisers reserve the right to refuse entry to any competitor. The Organisers reserve the right to modify or alter the race course to provide suitable riding conditions during the event. The Organisers reserve the right to change any team name if in the sole opinion of the Race Director the name conflicts with another team names or the team name is of an offensive nature.

I have carefully read this entry form and agree to abide by these race conditions. I agree to obey all the race rules, directions and decisions of all race officials whilst I am in the Event. All entrants must agree as having read and understood this declaration. This form, printed and signed by the rider and the rider’s parent or guardian must be brought to Race Registration on 21 June 2009 before you will be allowed to ride at the event, including riding for practice laps.
